About the Commission

The West Bengal Minorities' Commission (W.B.M.C.) is a statutory body under Minority Affairs and Madrasah Education Department, Government of West Bengal.

The Commission was constituted through enactment of the West Bengal Minorities' Commission Act 1996.

This body discharges functions as per Rule u/s 4 of West Bengal Minorities' Commission Act 1996. It functions as apex body in the State of West Bengal for the redressal of grievances of Minorities.

Muslim, Christian, Buddhist, Parsee, Sikh and Jain are the six religious groups who, enjoy the status of Religious Minority in this state.

Apart from that, people of six linguistic groups namely, Urdu, Hindi, Nepali, Odiya, Gurumukhi and Santhali are recognised as Linguistic Minorities under West Bengal Minorities' Commission Act 1996.

The Commission is constituted with one Chairperson, one Vice-Chairman and 9 other members from various Minority Communities. Out of 9 members, 6 members are from each religious community; there is one woman member and two open seats. Another 3 are ex-officio members – a) Member Secretary, West Bengal Minorities' Commission, b) Secretary, Minority Affairs & Madrasah Education Department & c) One nominated Representative from West Bengal Minority Development & Finance Corporation.

The tenure of each member is 3 years.

Power & Function of Commission

The Commission performs the following duties as described u/s 4 of West Bengal Minorities' Commission Act 1996: -

- a) Evaluate the progress of the development of Minorities of West Bengal and review implementation of the policies and programme of the State Government.
- b) Monitor the work of the safeguarding the Minorities provided in the Constitution and in laws enacted by Parliament or the State Government.
- c) Make recommendations for effective enforcement and implementation of safeguarding for the protection of the Minorities provided by the Central or State Government.
- d) Looks into specific complaints regarding deprivation of social, economic, educational, cultural and linguistic rights and safeguards of the Minorities and takes up such matters with the appropriate authorities.
- e) Sends Recommendation to the State Government to accord minority status to religious, linguistic, and ethnic groups, who do not enjoy any constitutional or statutory benefits or status.
- f) Cause studies to be undertaken into problems arising out of any discrimination against minorities and recommend measures for their removal.
- g) Conduct studies, research and analysis on the issues relating to socio-economic and educational development of minorities.
- h) Make Annual Report and send it to the State Government on any matter pertaining to any of the functions of the Commission.
- i) The Commission has the power of a civil court trying a suit while performing the functions under sub-section (1).
- j) The Commission shall, while investigating or enquiring into any complaints regarding violation or infringement of any rights of the Minorities as guaranteed by the Constitution or as conferred by or under any Central Act or State Act, shall have all the powers of a civil court trying a suit under the Code of Civil Procedure, 1908, and particularly, in respect of the following matters:
 - i. Summoning and enforcing the attendance of any person from any part of India and examining him on oath.
 - ii. Requiring the discovery and production of any document.
 - iii. Receiving evidence on affidavits.
 - iv. Requisitioning any public record or copy thereof from any court or office.
 - v. Issuing summons for the examination of witness, documents and any other matter which may be prescribed.



Meeting with Member of N.C.M.

Visit of Hon'ble Mr. Kersi Kaikhusroo Deboo, Member, National Commission for Minorities, New Delhi to West Bengal Minorities' Commission, Mirza Ghalib Street, Kolkata-87 on Monday i.e. 13.06.2022 at 10-00 a.m. and informal meeting was held at the Conference room of W.B.M.C.

Mr. Cyrus J. Madan, Hon'ble Member, from Parsee community, accompanied Hon'ble Mr. Kesri K. Deboo and was greeted with flower bouquets by Hon'ble Chairperson and MemberSecretary, W.B.M.C, Members from different communities were introduced to Hon'ble Member, N.C.M.

Member-Secretary, Chairperson and other persons gave a short account of activities of W.B.M. Commission. After introduction the Hon'ble Member, N.C.M. deliberated in the house regarding various initiatives by the Ministry of Minority Affairs, Government of India, in the field of educational empowerment, economic empowerment, special needs for empowerment and support to institutions. He highlighted Prime Minister's New 15 Point Programme.

Educational Empowerment

Mr. Kersi Kaikhushroo Deboo, Member, N.C.M. thoroughly discussed the following points-

- Pre-matric Scholarship, Post-matric Scholarship in the meeting.
- The fund is disbursed by Nationalized Bank to students for studying in M. Phil & Ph. D out of India.
- The rate of Interest of Bank is low.
- In order to avail the scholarship, the applicant has to apply online at National Scholarship portal site.

Scheme implementation

• It was also discussed to make recommendation for the effective implementation of safeguards for protection of minorities by the Central Government or the State Governments.

• Query of Hon'ble Chairperson regarding implementation of Central scheme, Member, N.C.M. was agreed that he would write letter directly to N.C.M.

❖ P.M.J.V.K. (Prime Minister's New 15 Point Programme)

P.M.J.V.K. Programme was discussed thoroughly in the meeting.

• The Central Plan Scheme of Madrasah Modernization Programme provides basic educational infrastructure in the field of backward minorities. The Central Government sanctions Rs.50 lakh for upliftment of Madrasah education.

Recruitment to State and Central Services

- 0.25% Minority Muslim are engaged in Delhi Government service.
- 0.5% Muslim Minority are engaged in Central Government service.
- In Gujarat 13% Muslim are engaged in Government service.

Wakf matters

• It was discussed by Member, N.C.M. that the fund of Haz has been increased.

Jain Society

• The Member, N.C.M, stated if third child is born then Rs. 5 lakh is given by Jain Trust to such family and education is free from school to college.

Term Loan

- It was discussed about Term loan for which two government guarantors are necessary.
- It was asked by the Board Members, W.B.M.C., for relaxation of two Government guarantors.

The meeting ended with the vote of thanks to and from the Chair.

Proceedings of the Programme:

Shri John Barla, Minister of State for Minority Commission was the Chief Guest.

The Conference began at 10:30 am with Shri Iqbal Singh Lalpura — Chairperson of The National Commission for Minorities welcoming the gathering and the Chief Guest.

Shri John Barla then addressed the congregation and extolled the virtues of the Commission and the 15 Point Programme of the Prime Minister for Minorities. He mentioned how the Commission was doing a great job and requested Minority members to always address their grievances to the Commission instead of launching agitations.

TECHNICAL SESSION 1 - ROLE OF MINORITIES IN DEVELOPMENT OF THE COUNTRY.

PANEL MEMBERS — Shri Prabhu Chawla (New Indian Express); Ms. Husnara Salim (Founder Maulana Azad Foundation), Shri Harmit Singh Kalra (Delhi Sikh Gurdwara Management Committee); Dr. Shernaz Cama, (Director Parzor Foundation); Shri Dhanyakumar Jinappa Gunde (Member National Minority Commission); Shri Kersi K Deboo (Vice Chairman National Minority Commission) and General J.J.Singh (Ex-Army Chief).

Each Panellist spoke for between 10 to 15 minutes, but frankly with there being no interaction between the members, there was a great deal of repetition and some deviated from the topic altogether. The summing up of what was put forward by Shri Gunde was exceptionally lengthy and it was laced with a great deal on the virtues of the Prime Minister.

TECHNICAL SESSION 2 - ROLE OF ADMINISTRATION TO ADDRESS PROBLEMS OF MINORITIES

PANEL MEMBERS — Shri A.C.Michael (President of Federation of Catholic Associations of Archdiocese Delhi), Shri Shanti Jain (Ex IPS), Ms. Syed Shahezadi (Member National Minority Commission), Ms. Rinchen Lhamo (Member National Minority Commission) and Dr. Manish Gawai.

Each Panellist spoke and Shri Michael was the most forthcoming and underlined the problems facing the Christian Community and asking people to come forward to help when they saw something wrong taking place. He brought up the example of Dr. Stan Swamy and how he had had to suffer. He also referred to a small demonstration that had taken place a few days earlier in Delhi which was talked about by the Honourable Minister John Barla in his speech. All his points were countered vociferously by the other speakers. Once again, the only message being put across was to visit the Minority Commission when facing problems, rather than going in for any agitation.

After the Speakers had finished, The Chairman of the National Minority Commission and all the Members of the NMC took the stage. At this juncture, they called Shri Gurbux Singh, Member of West Bengal Minorities' Commission and ex Olympian and Gold Medallist who was felicitated by the Chairman and all present for his outstanding contribution to sport. It was a proud moment for all of us Members of the West Bengal Minorities Commission.

The Chairman Shri Iqbal Singh Lalpuria then addressed the gathering and gave a lengthy discourse on what the National Minority Commission stood for and how they had achieved a great deal. His speech was followed by a break for tea and this in turn by an Open House Discussion.

AUDITORS' REPORT

Report on the Financial Statements

We have audited the accompanying financial statements of M/S. WEST BENGAL MINORITIES' COMMISSION ("the Commission") of Khadya Bhavan, Block A, Ground Floor, 11A, Mirza Galib Street, Kolkata – 700087 which comprise the Balance Sheet as at 31 March 2023, the Statement of Income & Expenditure and Receipt & Payment Account for the year then ended, and a summary of significant accounting policies and other explanatory information (Annexure A).

Management's Responsibility for the Financial Statements

In making those risk assessments, the auditor considers internal control relevant to the Commission's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.
